Teens Expectations of Conduct:

1. Listen and follow directions that staff give you
2. Be respectful of the facility and equipment, clean up after yourself.
3. Participate in activities.
4. Be respectful of other Teen Coalition members
5. No fighting, bullying, name calling or anything that would constitute violent behavior towards others or yourself.
6. No stealing or taking someone else's property
7. No vandalism
8. No possession of alcohol, cigarettes, or drug

Teen Coalition members are representatives of the Pueblo of Nambe and shall always represent Nambe Pueblo, Tewa Roots Society and themselves in a positive, mature, respectful way.

Teens must attend a minimum of 8 activities and at least 1 training a month to be eligible for quarterly retreats.

Responsibilities of Parent/Guardian:

2. If you are late in picking up your child and have not made prior arrangements with staff after three offenses your child will be suspended from the Teen Coalition for a week
3. You are to attend all mandatory parent meetings
4. You are to notify staff of any changes to this form or changes in phone numbers

Policy for not following expectation of conduct:

1. First offense verbal warning (unless it is #5, 6, 7, 8 of expectations of conduct)
2. Second offense will be to sit out from activity
3. Third offense parent will be called and teen will be sent home for remainder of the day
4. A mandatory meeting with staff, parent and teen will be called to create a plan of action
5. Termination from the program

Any teen who is not following safety instructions or is creating an unsafe environment during a meeting or activity will immediately be asked to sit out for remainder of activity.
